1. The person(s) named below (herein known as Adopter) has agreed to adopt the cat named above, from EveryoneNeedsAHome, Inc. (ENAH).
 2. The Adopter agrees to pay an adoption fee of \$_____. The adoption fee will be refunded within 30 days of adoption if the cat named above is returned to ENAH. After that time period, the adoption fee will not be refunded even if the cat is returned to ENAH.
 3. Unless it is too young, the cat will have been spayed/neutered by ENAH. If the cat has not yet been spayed or neutered, the Adopter agrees that the adopted cat will be spayed/neutered by _____ (date). If spay/neutering has not been done within this time frame and/or ENAH has not been notified as to why the operation has not taken place, then ENAH reserves the right to seize said cat. It is possible that ENAH can assist with the cost of spaying/neutering this cat through the ENAH Spay/Neuter Project. If you desire, please contact an ENAH representative when the cat is 6 months old to discuss enrollment in this project.
 4. ENAH makes no health guarantees for this cat. This is a rescued cat/kitten and, in most cases, of unknown background. Any known medical condition(s) of the animal has been fully disclosed to the Adopter. Medical conditions are to be listed below and initialed by ENAH representative and Adopter that medical conditions have been discussed.

5. The Adopter must be prepared to demonstrate his/her ability and willingness to provide proper food, medical care and a loving, safe, healthy, clean and permanent environment for the cat.
6. The Adopter agrees to maintain annual vaccinations, i.e. rabies, distemper, etc.
7. The Adopter will agree to and cooperate with a follow-up visit and/or phone call by an ENAH representative.
8. The Adopter agrees to keep this cat as a companion, living with him/her in his/her house. The Adopter agrees that this cat will be an indoor-only cat, that this cat will not be let outside, even for brief periods.
9. Cats rescued and rehabilitated by ENAH are typically affectionate and friendly. ENAH does not knowingly place any cat which has shown unsound temperament toward people. However, ENAH cannot guarantee the temperament of any cat it places. Some cats do not like other animals. The Adopter is urged to exercise prudence and caution introducing an adoptive cat into a new situation until the cat has become fully adjusted to its new environment and the Adopter has had an opportunity to become familiar with the cat's personality.

10. ENAH shall not be responsible for, and Adopter agrees to hold ENAH harmless from, any bodily injuries or property damage caused by any adoptive cat or by the actions of the Adopter. _____(initial)
11. The ownership and responsibility for the cat belongs solely to the Adopter. However, if for any reason the Adopter cannot keep the cat, the Adopter must contact ENAH and surrender the cat to ENAH. The Adopter shall not transfer ownership to any other party besides ENAH. _____(initial)
